## **Human Rights Committee 139<sup>th</sup> Session ICCPR Implementation Report United States of America (USA) October 15**

This includes a Shadow Report and an intervention prior to the start of the session in October of 2023. The American Civil Liberties Union (ACLU) and the International Indian Treaty Council (IITC) allows the Human Rights Committee to place Alaska and Hawaii under Article 27 of the Convention – Minority Rights. I objected to that. The puppet Chair of the Committee said her eyes blurred when our name came up to speak and would have not called on me, except the ACLU, who appealed to the Chair to call on me. They know press will listen to what I say. There was obvious counter-intelligence work going on that we quashed.

IHRAAM did one intervention for the Intergovernmental Working Group on Transnational Corporations and other business enterprise. I became ill and missed the rest of the week. The one intervention is being submitted. The Chair and his assistants thanked me for the intervention.

It must be noted that Ambassador Ronald F. Barnes continues to receive threats and intimidation due to his work in Geneva. The Indigenous Peoples and Nations Coalition (IPNC) and the Koani Foundation will inform the United Nations apparatus at all levels of our work and intimidation efforts by the United States of America functionaries to block our efforts at the United Nations, including requests to block Ambassador Barnes from being accredited, placed on panels and participating in the United Nations systems, some of which A. Majid Trambo is aware of. The USA asks States, Non-Governmental Organizations and others not to accredit, place on panels or to work with, in particular, Ambassador Barnes.
